

ABSTRAK

HUBUNGAN PENGETAHUAN TERHADAP PERILAKU MASYARAKAT TENTANG COVID-19 DI KELURAHAN KOMET KECAMATAN BANJARBARU UTARA (Oleh Nadia Ramadhan Nisa; Pembimbing apt. Rahmayanti Fitriah, M.P.H., apt. Esty Restyana Rusida, S.Farm., Kes.,: Banjarbaru: S1 Farmasi Sekolah Tinggi Ilmu Kesehatan Borneo Lestari)

Covid-19 adalah penyakit infeksi yang disebabkan oleh corona virus jenis baru yang merupakan penyakit pernapasan akut yang menjadi pandemik global dan disebabkan oleh novel coronavirus atau *SAR-Cov-2*. Covid-19 dapat menular dari orang yang terinfeksi kepada orang lain di sekitarnya melalui percikan batuk atau bersin. Perilaku yang tepat dalam pencegahan terjadinya penularan Covid-19 yaitu dibutuhkan kesadaran masyarakat dalam memperhatikan protokol kesehatan serta menjaga jarak dan meningkatkan imunitas tubuh salah satunya dengan mengkonsumsi suplemen. Tujuan penelitian adalah untuk mengetahui hubungan tingkat pengetahuan dan perilaku masyarakat tentang Covid-19 di kelurahan komet kecamatan banjarbaru utara. Sampel penelitian berjumlah 100 orang. Teknik pengambilan sampel menggunakan *Probability Sampling*. Uji yang di gunakan adalah uji *Normalitas* dan uji *Korelasi Pearson*. Kesimpulan menunjukkan bahwa tingkat pengetahuan masyarakat tentang Covid-19 di kelurahan komet mayoritasnya berpengetahuan baik sebanyak 63% dengan perilaku masyarakat tentang Covid-19 mayoritasnya cukup baik sebanyak 92%. Hasil uji statistik menunjukkan 0,019 ($< 0,05$) bahwa adanya hubungan erat yang berpengaruh antara tingkat pengetahuan terhadap perilaku masyarakat tentang Covid-19 di kelurahan komet kecamatan banjarbaru utara.

ABSTRACT

Covid-19 is an infectious disease caused by a new type of corona virus which is an acute respiratory disease that has become a global pandemic and is caused by the novel coronavirus or SAR-Cov-2. Covid-19 can be transmitted from an infected person to others in the vicinity by coughing or sneezing. Appropriate behavior in preventing the transmission of Covid-19 requires public awareness in paying attention to health protocols and maintaining distance and increasing body immunity, one of which is by consuming supplements. The purpose of the study was to determine the relationship between the level of knowledge and community behavior about Covid-19 in the Komet Village, North Banjarbaru District. The research sample amounted to 100 people. The sampling technique uses Probability Sampling. The test used is the normality test and the Pearson correlation test. The conclusion shows that the level of public knowledge about Covid-19 in the comet village is mostly good knowledge as much as 63% with the majority of people's behavior about Covid-19 being quite good as much as 92%. The results of the statistical test showed 0.019 (< 0.05) that there was a close relationship that influenced the level of knowledge on community behavior about Covid-19 in the Komet Village, North Banjarbaru District.
